

## **Digital Banking Sweepstakes Terms & Conditions**

### **Contest Rules:**

This promotion is subject to all applicable federal, state and local laws and IRS regulations and is void where prohibited. This promotion shall be governed by and construed in accordance with the laws of the State of Michigan. All participants agree to these terms and conditions by participating in this promotion.

### **Eligibility:**

No purchase is necessary to win, and making a purchase will not improve the chance of winning. The promotion is open only to legal residents of the fifty (50) United States and the State of Michigan who are 18 years of age or older. Void where prohibited by law. Employees, directors and officers, and their immediate families (spouse, parents, children, siblings, and their respective spouses, regardless of where they reside), and their respective household members, whether or not related, of West Shore Bank, and affiliated companies are not eligible to enter. The Contest is subject to all applicable federal, state, and local laws and regulations.

### **How to participate:**

Eighth Street, Traverse City, MI 49685. Mail-in entries must be postmarked by one of the following dates: February 5, 2026 and received by the third business day following that date to be eligible.

### **Drawings, Determination & Notification of Winners:**
